## Featured News

**UNGA gives the green light to IPBES:** During a plenary meeting held in New-York on 20 December 2010 the United Nations 65th General Assembly (UNGA) approved the creation of an Intergovernmental Platform on Biodiversity and Ecosystem Services (IPBES). Governments gave a green light to its establishment in June 2010 at a meeting in Busan, Republic of Korea, coordinated by the UN Environment Programme (UNEP), but this required a resolution to be passed at the UNGA. The independent platform will in many ways mirror the Intergovernmental Panel on Climate Change (IPCC), which has assisted in catalyzing worldwide understanding and governmental action on global warming. The new body will bridge the gulf between the wealth of scientific knowledge on the accelerating declines and degradation of the natural world, with knowledge on effective solutions and decisive government action required to reverse these damaging trends. Its various roles will include carrying out high-quality peer reviews of the wealth of science on biodiversity and ecosystem services emerging from research institutes across the globe in order to provide gold standard reports to governments. These reports will not only cover the state, status and trends of biodiversity and ecosystems, but will also outline transformational policy options and responses to bring about real change in their fortunes.

**2011 is the International Year of Forests:** The United Nations General Assembly has declared 2011 as the International Year of Forests to raise awareness on sustainable management, conservation and sustainable development of all types of forests.

## News from PCLG Friends

**CBD CoP 10:** The final report of the Tenth Meeting of the Conference of the Parties to the Convention on Biological Diversity, and the final version of the Decisions from CBD CoP 10, are now available for download [here](#).

**CPALI:** The following are some of CPALI's achievements during 2010:

- Completed planting of over 10,000 trees on 40 hectares of family farms and border forests of Makira.
- Made a financial commitment to set-up 60 farmers with 40 more lined up to work with CPALI pending funding.
- Established copyright protection for two styles of non-spun textile.
- Trained 5 women to make the textile to CPALI's specifications.

In the coming year CPALI's goals are just as ambitious: expand its program to 500 silk-producing farmers and develop a marketable stream of wild silk textiles; initiate ecological and economic monitoring and negotiate contracts with some of the businesses with whom CPALI is in contact. If all this succeeds, CPALI's program will be sustainable by 2013.

**Proceedings of the 12th Annual BIOECON Conference "From the Wealth of Nations to the Wealth of Nature: Rethinking Economic Growth":** The 12th Annual BIOECON Conference, held in Venice on 27-28 September 2010, was devoted to the identification of the most effective and efficient instruments for biodiversity conservation, such as auctions of biodiversity conservation contracts, payment-for-services contracts, taxes, tradable permits, voluntary mechanisms and straightforward command and control measures. In addition, a significant portion of the research presented in the conference has focused on analysing the impacts and dependencies of different businesses on biodiversity and ecosystems, and the potential contributions of corporations to a more resource-efficient economy.

IISD RS is pleased to announce that the newest issue of MEA Bulletin is now available. The **107th issue of MEA Bulletin** includes reports on: the first Intersessional Meeting for the 2012 UN Conference on Sustainable Development (UNCSD, or Rio+20) and preparations for UNCSD; preparations for the first meeting of the Intergovernmental Committee for the Nagoya Protocol on Access to Genetic Resources and the Fair and Equitable Sharing of Benefits Arising from their Utilization; and efforts by the Convention on Migratory Species for the adoption of an action plan to ensure the conservation of migratory grassland birds and their habitats in South America. ## New Organisations in our database

**Albertine Rift Conservation Society (ARCOS):** ARCOS is a non-governmental organisation established in 1995 whose

mission is to enhance conservation of critical ecosystems and promote sustainable development in the Albertine Rift through collaborative actions between various partners in the region.

**Frankfurt Zoological Society (FZS):** FZS was established in 1858 and is an internationally operating conservation organisation based in Frankfurt/Main. The Society's main focus lies in eastern Africa, although its work has expanded in recent years to include Eastern Europe, South America and Asia. FZS' work is committed to conserving biological diversity.

**International Conservation and Education Fund (INCEF):** INCEF is a nonprofit organisation dedicated to the concept that a commitment to strategic communication is a prerequisite to positive changes in attitudes and behavior regarding the nexus of wildlife conservation, public health and economic development in underdeveloped and/or overly exploited areas of the planet. INCEF's approach focuses on the use of locally produced and disseminated video as an educational tool to foster improvement of the health and well-being of human and wildlife populations.

## Forthcoming Events

**16th Poverty Environment Partnership Meeting:** The sixteenth Poverty Environment Partnership (PEP 16) meeting will be held from **16th to 18th February 2011 in Vienna**, and feature the theme "Supporting nationally owned Green Economies to achieve the MDGs and respond to climate change".

**Nature™ Inc? Questioning the Market Panacea in Environmental Policy and Conservation:** In order to respond to the many environmental problems the world is facing, new and innovative methods are necessary and markets are posited as the ideal vehicle to supply these. This conference, which will take place on **30th June – 2nd July, 2011, in The Hague, The Netherlands**, seeks to critically engage with the market panacea in environmental policy and conservation in the context of histories and recent developments in neoliberal capitalism.

**4th World Conference on Ecological Restoration:** The Society for Ecological Restoration (SER) and its partners from Latin America invite you to **Merida, Mexico, on August 21-25, 2011** for SER's 4th World Conference on Ecological Restoration. The theme of SER 2011 is "Re-establishing the Link between Nature and Culture". SER 2011 will be an important forum for addressing the global challenges of biodiversity and habitat loss, climate change, and sustainable development. It will provide a global venue for professionals, researchers, students and the public to come together, learn and share their knowledge and experiences, and identify practical solutions for restoring nature and sustaining critical ecosystem goods and services.

**ACES 2011: Conservation Conflicts: Strategies for coping with a changing world:** This conference will take place from **22nd to 24th August 2011, at the Arts Centre in Aberdeen, Scotland, UK**. As human pressures on the planet increase, biodiversity is under growing pressure across the world. Changing patterns in land use, over-exploitation, pollution, climate change and the threat posed by invasive species, all challenge the way we currently manage and conserve biological diversity. Consequently, there are increasing numbers of conflicts between those interested in conserving species and those with alternative goals, interests or values. These conflicts occur over a range of scales from the local management of single species to international conflicts over the management of resources; they are multi-dimensional, involving ecological, social and economic interests and operate within political and legal frameworks. This conference brings together academics from a range of disciplines, policy makers and practitioners to address how, when and why conflicts arise, and to identify mitigation strategies.

**World Conservation Congress:** The 2012 World Conservation Congress will be held from **6th to 15th September 2012 in Jeju, Republic of Korea**. Leaders from government, the public sector, non-governmental organizations, business, UN agencies and social organizations will discuss, debate and decide solutions for the world's most pressing environment and development issues. The 2012 Congress aims to put nature and conservation at the top of the global agenda.

## New Publications in our database

**[The Evolution of Benefit Sharing: Linking Biodiversity and Community Livelihoods](#), by Morgera, E., Tsioumani, E., July 2010, *Review of European Community & International Environmental Law*, Vol 19 No 2, Wiley Interscience, pp. 150–173:** This article traces the evolution of the use of the legal concept of benefit sharing in the context of the Convention on Biological Diversity (CBD), with a view to highlighting its contribution to indigenous and local communities' livelihoods. To this end, the article proposes a distinction between inter-State benefit sharing (as identified in the third CBD objective and as usually linked to access to genetic resources) and notably lesser known State-to-community benefit sharing (in relation to the conservation and sustainable use of biodiversity). The article highlights the different legal connotations of the two dimensions of this legal concept, while supporting an integrated interpretation of the CBD. It points to a wide array of benefit-sharing-related tools under the CBD that can be used to support indigenous and local communities' livelihoods in pursuing the convention's three objectives. The article also identifies other international processes – in the areas of intellectual property, health and climate change – in which these conceptual developments may have a significant influence.

**[Current Challenges for Addressing Poverty Alleviation Via Vicuña Management in Andean countries](#), by**

**Lichtenstein, G., September 2010, Biodiversity, Vol 11 No 1 & 2, pp. 19-24:** Vicuña (*Vicugna vicugna*) are South American camelids, the commercial use of which has untapped poverty alleviation potential. Vicuña fibre is produced by extremely low income communities that inhabit the harsh environment of the high Andes in Argentina, Chile, Peru and Bolivia. At the other end of the world, affluent consumers are willing to pay high prices for apparel made of vicuña fibre. Vicuña management projects follow the logic of community-based wildlife management. The rationale for vicuña conservation through sustainable use is that commercial utilization of fibre obtained from live-shorn individuals will generate sufficient economic benefits to outweigh the costs of conservation, and contribute to community development and poverty alleviation. However, while conservation efforts have been extremely successful with vicuñas having recovered from the brink of extinction, the socio-economic achievements have thus far proved modest. Most such benefits are being captured by traders and international textile companies, rather than by local communities. In addition, the high market value of vicuña fibre has attracted a number of groups interested in its production. This threatens the conservation of this wild species, the exclusive rights of Andean communities and could undermine the spirit of the Vicuña Convention. This paper explores multiple-objective projects that address vicuña conservation and poverty alleviation and analyses the challenges that limit a more equitable distribution of benefits among stakeholders.
